To be eligible for USEF Awards including Farnam®/Platform™ USEF Horse of the Year Program you must be a Senior Active, Junior Active, or Life Member. By submitting this application, you agree all information is correct and you agree to abide by all USEF rules. Annual dues for Senior and Junior members include \$16 for a one year non-deductible subscription to equestrian magazine.
