Horse stabling and requirements

All horses will be required to have a current Coggins (1 year) and Health Certificate (30 days). I have included the Health requirements for the Gladstone facility, so please read carefully. This information is also available at www.uset.org Horses will be stalled overnight in the permanent barn facility at the USEF Headquarters in Gladstone. The Clinic fee covers one stall for Thursday, Friday and Saturday nights. Bedding is provided.

There will be no overnight camping on site. There are several hotels within a short drive of Hamilton Farms. A list of hotels, and a map to Hamilton farms will be sent once you have registered for the clinic.

Helmets are to be worn when mounted. Mornings can still be rather cool, so bring a light jacket, just in case.

USET FOUNDATION NEWS

EHV Vaccination Required for all Horses Entering USET Foundation Property

By USET Foundation Category: ALL DISCIPLINE Posted March 27, 2007

All horses entering USET Foundation property for clinics/events must have been immunized for Equine EHV-1 (either modified live or killed vaccine) no later than 90 days prior to arrival on the property. This means if your vaccine is over 90 days old by the time you are entering the grounds at the USET Foundation, you must update the vaccine no later than 5-7 days before the event you plan to attend. Show Managers for the various events will require proof of the vaccine PRIOR to entering the grounds. This proof must show date vaccinated, name of vaccine given (ie: Rhinomune, Fluvac Innovator, Calvenza, Pneumabort K, Resequin, or other), vaccine serial number and date and be signed by a licensed veterinarian.

THERE ARE NO EXCEPTIONS.

The necessary form is included here.

EVERY HORSE ENTERING USET FOUNDATION PROPERTY MUST HAVE THIS FORM SUBMITTED TO THE SHOW MANAGER OF THE EVENT YOU PLAN TO ATTEND PRIOR TO ARRIVING ON THE GROUNDS.

Given the fact that new cases of the Equine Herpes Virus continue to be reported, most recently in Virginia, health officials agree that the best protection is to be diligent with the vaccine. While we understand that the vaccine is not universally effective in preventing disease, it has been shown that horses that are vaccinated more frequently have fewer symptoms and a much more positive outcome if exposed to the virus.

During the next few months the USET Foundation facility will host many clinics and horse shows, as well as the Dressage Festival of Champions and Pan American Games Selection Trials. With all of the horse traffic due to come through the facility, it is imperative that we implement this policy for the safety of all horses.

REQUIREMENTS FOR ENTRY INTO THE USET FOUNDATION PROPERTY

ALL horses entering the USET Foundation property must submit this certification statement **PRIOR** to entering USET Foundation property. This certification form should be submitted to the show manager of the event(s) you are attending **PRIOR** to your arrival on USET Foundation property. **This certification must be signed by a licensed veterinarian.**
